Invasive Species, can I help?

This District has been working over the past year to obtain proper permitting to manage and different types of invasive species that have invaded Goose Pond.

You may ask yourself if there is something I can to help treat and maintain the invasive species in Goose Pond. Well, there is! The Department of Conservation and Recreation developed a program to train local lake groups to monitor the invasive species in their ponds. This program is on a volunteer basis and will train local residences on how to identify what an invasive species looks like, how to properly remove the invasive plants and what procedures are required to permit and report. Benthic Mats

There are a number of benthic mats located in Goose Pond. A benthic mat (also known as a benthic barrier/weed mat/bottom screen) is a mat that is installed at the bottom of a body of water to prevent or inhibit the growth of aquatic plants. It consists of a dark fabric or material that blocks sunlight and is held against the bottom by weights. Without sunlight, plants cannot photosynthesize and do not grow. These are typically found at the beach areas and, when properly maintained, are affective to control lake weeds. However, when unmaintained, sediment accumulates on the mats and weeds grow or they begin to pull up, and become a nuisance and swim hazard.

The District has reached out to a number of local paper mills in the area to see if they are willing to donate their used paper felts to the District for use around the lake. These felts have the same features as a benthic mat or weed barrier. Over the winter Tim Puntin has been integral in coordinating, organizing and obtaining these mats. Tim, along with other lake members, spent a number of weekends placing the mats on areas which previously contained phragmites. As we obtain more, the District will engage divers to install the mats at the beach areas and other areas where phargmites and milfoil are abundant. .

Committee Vacancies

The Committee expects to have a vacancy at the upcoming annual meeting, and potentially additional vacancies in the upcoming years. Each year a different member of the Committee is up for re-election and the item is addressed and voted on at the Annual Meeting. In advance of the meeting the District would like to reach out to see if any of its members have an interest in volunteering on the Committee. If so, please feel free to reach out to any Committee member or the District Superintendent.

Our Friends at Canyon Ranch

The District is beginning to establish a good relationship with the activities director at Canyon Ranch. Canyon Ranch frequently uses the lake during the summer for a number of activities, and they properly obtain all the required use permits. They have enjoyed Goose Pond for a number of years and would like to open up dialog about how they can give back to the community. Canyon Ranch has expressed an interest in donating to the District to assist with the ongoing maintenance and preservation efforts of the Pond. We thank Canyon Ranch for their donation and look forward to a wonderful relationship.

Fish Stocking

Mass Wildlife reports that close to 500,000 fish will be restocked into the streams, lakes and ponds in the Commonwealth this spring. A variety of fish included Eastern Brook, Brown, Rainbow and Tiger trout have been stocked in waterbodies across the state since early March. Mass Wildlife website reports that Goose Pond was restocked with Eastern Brook Trout and Goose Pond Brook was stocked with Brown Trout in April 2017. Stocking also took place in the fall of 2016, so grab a pole and head out!
